TWRW Officer Installation Senator Brandon Creighton

On August 26, 2014, Senator Brandon Creighton was sworn into the Texas State Senate to represent the citizens of District 4, which encompasses parts of Montgomery, Harris, Chambers, Jefferson, and Galveston Counties.

During his tenure as Senator, he has taken the lead on key issues that matter to Texas job creators including franchise and property tax relief, water and transportation infrastructure, and border security.

Before election to the Texas Senate, Creighton served as State Representative for District 16 where his peers elected him to Chairman of the Texas House Republican Caucus. He also served as Chairman of House Federalism Committees tasked with overseeing the state's relationship with the federal government and ensuring that Texas' constitutional rights are protected.

Throughout his legislative career, his priorities have distinguished him as a genuine defender of conservative values. He has relentlessly hammered excessive taxation, pursued "loser pays" tort reform, passed drug testing for unemployment benefits, stood up for Texas' 10th Amendment rights, and effectively blocked Obamacare's Medicaid expansion.

Brandon is an eighth-generation Montgomery County resident, where he resides with his family. He is a graduate of the University of Texas and holds his Doctor of Jurisprudence from Oklahoma City University School of Law. In his spare time, he enjoys Texas history, sports, hunting, and fishing.

President - Jessica Hart Steinmann

Jessica is the President of The Woodlands Republican Women for 2023 and was previously the Campaign Activities Chair for the Club. During 2023, the club has grown almost 40% in membership and has had more than 50% growth in funds.

Jessica also serves on the Texas Federation of Republican Women (TFRW) Board as the Youth Outreach Chair and is the Texas Youth Outreach Chair for the National

Federation of Republican Women (NFRW). She has also served on the Election Committee for TFRW and was a speaker at the last TFRW Convention. In 2017 she was named a National Future 40 under 40 by MavPac, and in 2023 named 40 Under 40 by TFRW.

Jessica serves as General Counsel and Director of Litigation for the America First Policy Institute, a think tank created by senior officials from the Trump Administration. In this role, she oversees the legal operations for the organization and also brings litigation that furthers the American way of life and protects our Constitution.

Previously, she served as a senior official for the Trump Administration at the Department of Justice (DOJ). She was appointed by President Trump as the Director for the Office of Victims of Crime at the DOJ where she oversaw nearly \$9 billion (funding financed by fines and penalties paid by convicted felons, not from taxpayer dollars). Her office provided the largest federal funding to combat domestic human trafficking.

She previously worked for U.S. Senator Ted Cruz, the Texas House, the Harris County Republican Party, and started her career as a commercial litigation attorney at Bracewell & Giuliani, LLP in Houston.

She currently serves as a Director of the Texas Lyceum, is a member of the Conroe Noon Lions Club and The Woodlands Rotary and previously served as the President of the Houston Young Lawyers Association and the Chair of the Houston Holocaust Museum's Next Generation Leadership Board. She graduated in the top of her class from Baylor Law School, where she also served as managing executive editor of the Baylor Law Review and was elected class president of her law school class all three years of law school. She attended undergrad at the University of Texas at Austin where she double majored in Finance and Business Honors Program with a minor in government.

Jessica is married to Montgomery County Clerk Brandon Steinmann. Jessica and Brandon welcomed a baby boy, Luke, a year ago.

1st Vice President, Programs - Rebecca Smith-Nash

Rebecca has previously served as the 2nd Vice President of Membership and Chair of Outreach for the Club.

Rebecca is a Licensed Professional Counselor and Supervisor. Rebecca facilitates workshops and training programs on various topics related to high conflict divorce and custody modification, adduction, and foster care.



Rebecca graduated with Honors from Southwest Texas State University with a Bachelor's Degree, graduated with Honors from Sam Houston State University with a Masters of Arts in Counseling, and attended a PhD program for Counseling, all but dissertation.

Rebecca is the Founder and CEO of Counseling Center of Montgomery County, Love Heals Youth, and Allied Coparenting and Family Academy. Rebecca has also developed a comprehensive internship program for aspiring counselors to complete their hours for their Master's degree program and to fulfill their 3,000 hour post-graduate clinical requirements for full licensure. Rebecca has served over 7,000 families through her practices and trained over 200 counselors.

Rebecca is the past president of the board of directors for the Texas Chapter / Association of Family and Conciliation Courts. She is the past president of the board of directors for Access Builds Children and the Vice President for the Child Protective Services nonprofit board of directors. She was also appointed to the Montgomery County Child Welfare Board of Directors by our Commissioner's Court. Rebecca has served on the board of directors for Texas Mental Health Counselors Association. Rebecca is the Treasurer of the Board of Directors for the nonprofit Conroe Founder's Day. She has served as a member of several committees for other nonprofit organizations. Rebecca is a 2021 graduate of Leadership Texas Women and 2022 graduate of Leadership Montgomery County. Outside of mental health, Rebecca is part of the Conroe Noon Lions Club, serving individuals with disabilities.



2nd Vice President, Membership - Molly Smith

Molly attended Sam Houston State University but completed her bachelor's degree, Magna cum laude, and master's degree at Old Dominion University, Norfolk, VA. She taught high school business classes in Virginia Beach and Woodbridge, VA. After teaching for 11 years, she pursued a civil service career and served as the Chief, Testing Branch, US Military Entrance Processing Command, San Francisco, CA, and as a program analyst with the US Marine Corps Operational Test & Evaluation

Activity, Quantico, VA. In addition, she served as an inspector and auditor with the Department of Justice, Office of the Inspector General, Washington, DC, and the Inspector General's Dallas Regional Audit Office, Dallas, TX. Molly transitioned from the Department of Justice to the Department of the Navy and served as analyst, Commander, Navy Installations Command, Washington, DC, and as the Inspector General for Commander, Navy Region Marianas, Guam. She also served as the Inspector General for Commander, US Naval Forces Central Command/Commander US FIFTH Fleet, Bahrain. While working she was a Certified Government Financial Manager and Certified Inspector General and held a Commonwealth of Virginia Postgraduate Professional License.

Her awards included Department of Justice, Special Achievement Award; Navy Meritorious Service Award; Superior Civilian Service Award; and Secretary of Defense Medal for Global War on Terrorism.

Molly married her high school sweetheart Wayne, of Tenaha, and was happily married for 38 years until his passing. Wayne was career Navy for 31 years, which is the reason for her many career changes. She is also blessed to be the grandmother of three: Avery, senior at Kansas University; Austin, junior at South Dakota State University, and Aubrie, senior at College Park High School.

Americanism Report: The Forgotten War of 1812

George Washington wrote, "A free people ought not only to be armed and disciplined but ... have sufficient arms and ammunition to maintain ... independence from any who might attempt to abuse them, which would include their own government."

India's founder, Mahatma Gandhi, a man known to eschew violence, declared, "Among the many misdeeds of ... British misrule in India, history will look upon the act of depriving a whole nation of arms as the blackest."

In America today, the Second Amendment is under attack. Left-leaning retired Supreme Court Justice John Paul Stevens argued that Democrats should "get rid of the Second Amendment."

Thoughtful reflection will confirm the 2nd Amendment right to "keep and bear arms" gives the citizenry the power to protect all other rights against enemies both domestic and foreign.

In the Federalist Paper No. 29, one of the 85 essays collectively published by Alexander Hamilton, James Madison, and John Jay advocating ratification of the Constitution, Hamilton recognized the importance of forming a "select corps" of professionalized militia. This "select corps" would be the "best possible security against a large standing army." It would be "a large body of citizens, little inferior in discipline and the use of arms, who stand ready to defend their own rights and those of their fellow-citizens"

Hamilton recognized the importance of ensuring that "people at large" are "properly armed and equipped," in tandem with the professionalized or select corps of citizensoldiers.

Richard Henry Lee, a contemporary of Hamilton, stated, "To preserve liberty, it is essential that the whole body of the people always possess arms, and be taught alike, especially when young, how to use them." The October 7, 2023 invasion of Israel by Hamas terrorists underscores the importance of an armed citizenry for self defense. It may surprise you to learn that the most heavily armed citizenry in the world are the Swiss. Having a trained and armed citizenry has helped Switzerland maintain neutrality for more than 200 years.

I leave you with remarks from President Ronald Reagan at the annual convention of Kiwanis International, July 6, 1987: "Freedom is never more than one generation away from extinction. It has to be fought for and defended by each generation."

God bless Texas and the USA!
